LAB TESTS AND PRESCRIPTIONS ARE PAID FOR AS APPROPRIATE. HEALTH PARTNERS FREE CLINIC INCORPORATED IN 1998 AND IS NOW PROVIDING ITS 20TH FULL YEAR OF MEDICAL SERVICES TO THE COMMUNITY. MORE THAN 13,400 INDIVIDUALS HAVE RECEIVED TREATMENT THROUGH THE WEEKLY CLINICS. DURING 2019, MORE THAN \$2.1 MILLION WORTH OF HEALTH CARE WAS GIVEN AT NO EXPENSE TO THE PATIENT.
